# Public Policy Specialist

## 37.5 hrs/week, Exempt Position - \*Salary Range \$52,000 - \$60,000

The Public Policy Specialist is an important member of our team helping us to craft and inform public policy that directly impacts sexual and domestic violence survivors, their families, and our communities. This position reports to the Executive Director and is based in Juneau with in-state and national travel.

### Major Areas of Responsibility

### Research, Monitor, and Inform ANDVSA Prioritized Policy Projects

- Monitor and respond to Network prioritized state departmental regulations that affect victims of domestic violence and sexual assault. Troubleshoot and advocate on ongoing regulatory and other policy issues, working with partner stakeholders, state officials, organizations with which the Network has MOUs, and other resources.
- Collaborate with ANDVSA staff on ANDVSA prioritized policy efforts.
- Participate in statewide projects by representing ANDVSA on committees and on task forces.
- Work closely with ANDVSA program directors to ensure greater coherence between policies, proposed legislation, and practices.

### Provide Technical Assistance to Member Programs and Partners

- Serve as ANDVSA staff to legislative and policy committee by attending meetings, taking and disseminating minutes, and researching key issues.
- Work with the Executive Director on state and federal legislative and budget items; coordinate analysis and planning efforts with other agencies and organizations; research various policy and legislative topics, and ensure Executive Director and member programs are fully informed.
- Provide technical assistance to and consultation with local domestic violence service providers and allied professionals throughout Alaska. Technical assistance may include on-site support as well as telephone consultation, research and provision of resource materials such as policy advocacy training resources.

### **Track and Monitor Federal Policy Trends**

- Liaise with national advocacy groups to ensure Alaska is represented in national conversations.
- Keep member programs informed of federal trends. Track federal policy action requests and resources, and organize and disseminate to members.
- Assist with preparing for policy advocacy in Washington, DC during policy advocacy days.

### Provide Technical Support During Legislative Session

• Provide talking points and briefing notes to the Executive Director to inform public and written testimony.
