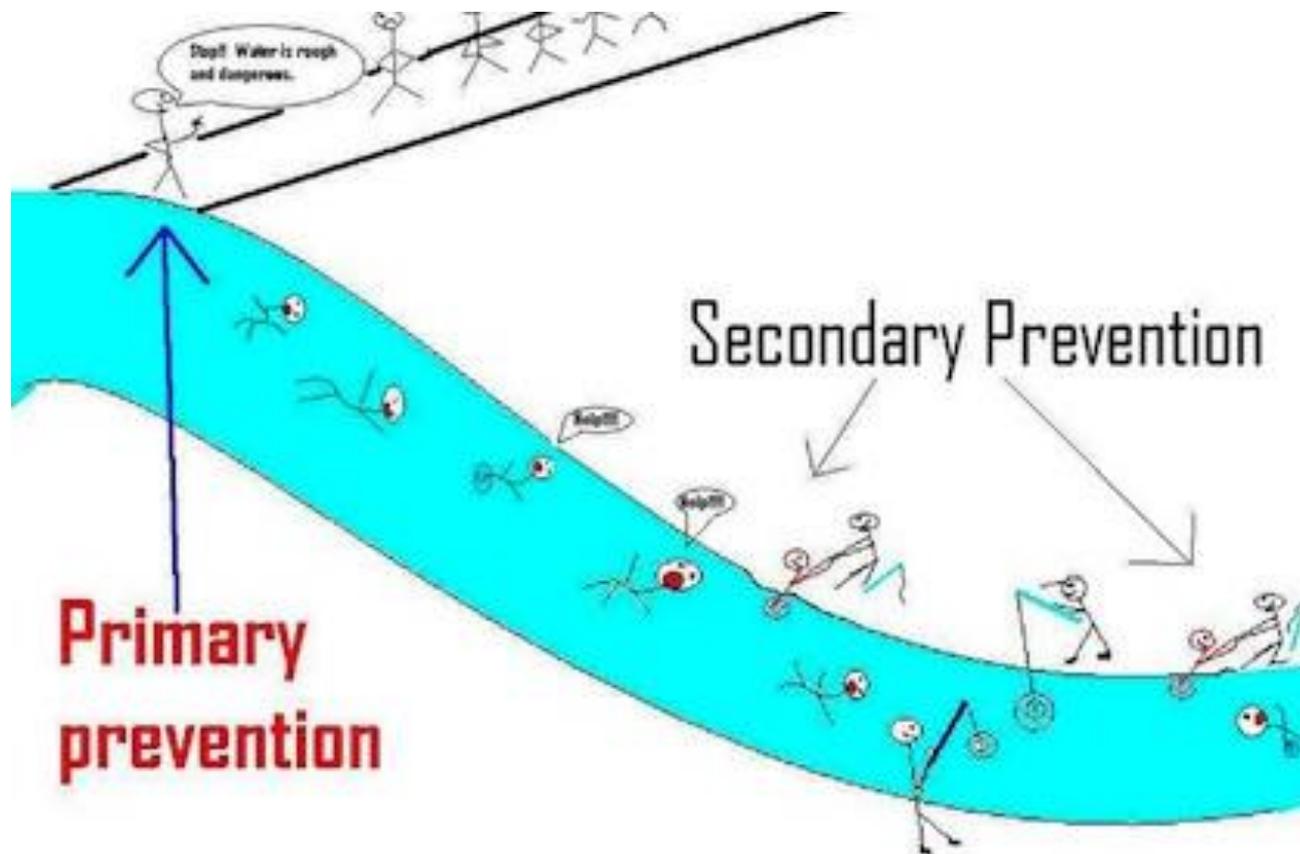

- ❑ Increased awareness and responsiveness
- ❑ Ability to monitor incidents, outcomes
- ❑ Improved school safety
- ❑ Supports social norms change

# Building Momentum: POV & LAUSD Partnerships

- 2009 Start Strong Initiative
- 2011 LAUSD School Board passes Preventing TDV and Promoting Health Relationships Policy Resolution
- 2012 Services, Education, Training, and Policies to Reduce Dating Violence, Sexual Violence and Stalking in Secondary Schools Grant (STEP Grant)

# Policy Components

1. Prevention Coordinator
2. Prevention Liaison
3. Education for Students
4. Training for Staff
5. Parent Engagement
6. Response to Dating Abuse
7. Reporting Incidents
8. Monitoring Program
9. Notice to Parents and Students



# Training and Implementation

- Staff development
- Classroom lessons
- Parent sessions
- Print and online resources
- Student safety or climate survey
- Youth leadership (STOP Clubs)
- School and community task forces



# STEP Grant

- Pilot full policy implementation in 2 middle schools and 1 high school
- Flesh out and expand Resolution for campus level implementation
- Integrate TDV, SA, stalking response into discipline matrix

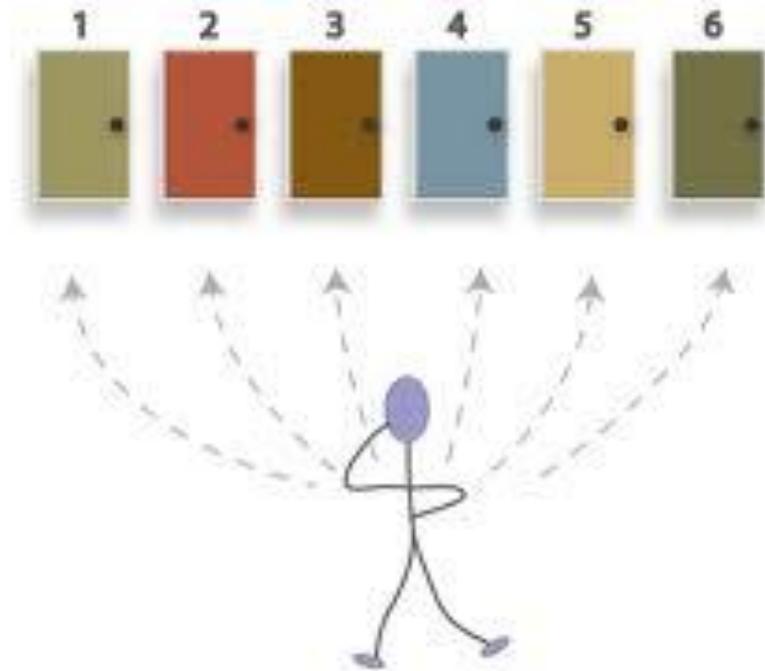

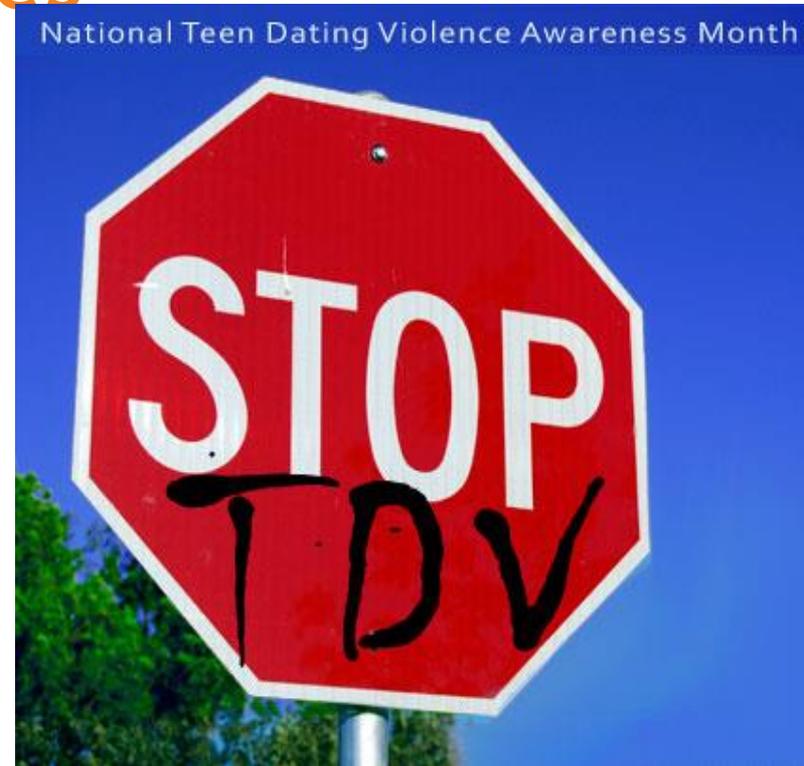

# Beyond Schools: Planning and Policy Development in the Community

- ❑ Enhance policies/programs in youth organizations
- ❑ Identify relationship indicators for children's social and emotional health

# Challenges

- ❑ Lack of awareness/prioritization of teen dating violence and its impact
- ❑ Lack of local data to substantiate need
- ❑ Competing community interests
- ❑ Limits of policies as prevention tools
- ❑ Difficulties with implementation and dissemination of policies
