- 1. Provides behaviorally focused support services to victims of domestic violence to increase understanding of dynamics of abuse, safety planning, self-esteem and self-soothing techniques to victims of domestic violence.
- 2. Maintains accurate and complete records as well as maintain their confidentiality.
- 3. Attend regularly scheduled trainings and team meetings as assigned.

- 2. Completed 40 Hour Domestic Violence Advocate Certification.
- 3. Understanding of the peer support model and Center for Domestic Peace' feminist analysis of domestic violence.
