Why the Partnership, CalCASA and CALICO?

- Approached by OES
- Quicker distribution of funds
- Support targeted for the field beyond members and OES grantees

Funding

- ► Total \$5.3 Million in VOCA funds
 - ► Partnership: \$3,000,000
 - ► CalCASA: \$1,600,000
 - ► CALICO (Child Abuse Listening, Interviewing and Coordination Center) \$721,337
- ► Funds expire this year and must be expended in the period January 1, 2020 July 31, 2020
- ▶ No agency can receive more than \$75,000 from a combination of all 3 awarding agencies.
- ► No match requirement

Who Is Eligible

- ► Any organization providing victim services may apply.
 - Sexual Assault (apply to CAL CASA)
 - ► Domestic and Intimate Partner Violence (Apply to Partnership)
 - ► Child Abuse (apply to CALICO)
 - ► Human Trafficking (may apply to any)
- Agencies may apply to more than one fund
- ► 501(c)(3) designated

What expenses are eligible?

Direct Victim Service Related to COVID 19:

- Emergency shelter/housing
- ► Emergency food/clothing/personal care items (gift cards ok)
- Utility assistance

Tech Needs to Serve Victims Remotely Because of COVID 19:

- ► IT support
- ► Laptops/tablets/hotspots
- Mobile Phones
- Cell/data services
- Video conferencing memberships
- AV equipment
- Hazard Pay (must have appropriate policies in place)
- Administrative Time Off (must have appropriate policies in place)
- Overtime

Other needs directly resulting from the Pandemic

Timeline

- ► May 7th and May 8th Informational calls
- ► May 6th Release the RFP
- ► Review applications each Friday on a rolling basis, notify awardees the following Monday.
- ► May 25, estimated earliest the Partnership will be able to release funds to subawardees
- ► Awards MUST be spent by July 31.
- ► Final reporting and invoicing due Aug 14, 2020

Application Process

- ► The initial application is an online form including some narrative of need and a simple budget
- Partnership staff will review and make funding determinations
- Once the application is approved with an approved total budget awardees must submit:
 - Subawardee facesheet
 - ▶ Detailed budget
 - Certifications
- ▶ Partnership staff will be available to provide TA with the application
